Minutes of the meeting of the Chairperson, Oversight Committee with the Chief Secretary, GNCTD, Commissioners of DMCs, Commissioner of Inds and the Chairman, DPCC on 30.10.2019 at 11.00 AM in the Conference Room of the Chief Secretary, 5th Level, Delhi Secretariat, IP Estate, New Delhi-110002.

Chairperson of the Oversight Committee headed by Justice (Retd.)Pratibha Rani Committee, constituted byHon'ble National Green Tribunal (NGT)in OA No. 601/2018 titled MayankManohar&Paras Singh, Reporter Times of India Vs Govt. of NCT of Delhi &Ors, convened a meeting to expedite the finalization of the recommendations in OA No.159/2019, OA No.601/2018 and OA No.56(Thc)/2013. The meeting was held on 30.10.2019 at 11.00 AM in the Conference Room of the Chief Secretary, 5th Level, Delhi Secretariat, IP Estate, New Delhi-110002 and was co-chaired by Chief Secretary, GNCT. The officers who attended the said meeting are listed as **Annexure-1**. Decisions taken in the said meeting are as under:

- 1. Chairperson welcomed the Chief Secretary and all the officers invited to attend the said meeting.
- 2. All the Officers were apprised about the directions of Hon'ble National Green Tribunal in OA No. 159/2019, OA No.601/2018 and OA No.56(THC)/2013 whereby the Oversight Committee has been directed to furnish its final report setting out its recommendations cumulatively at one place in a tabular form on or before 31.10.2019.
- 3. Attention of all the Officers was invited to various emails inviting information on the points :

-Action Taken in each of the matters related to the Organisation
-Action yet to be taken in the matter pertaining to the Organisation.
-Problems being faced by each of the agency in achieving the compliance of the directions issued by the Hon'ble NGT.
-Suggestions, if any, to achieve complete compliance of the directions of the Hon'ble NGT.

4. The Chairperson read over the responses received from the three DMCs and highlighted how the reports lacked material information and it was not possible to make any recommendations on the basis of incomplete/inadequate response. The Chairperson desired that the problems being faced by them in implementing the

orders, suggestions, if any, to overcome the problems and any other suggestion on the requirement of man-power and funds, if any, be highlighted, if felt necessary.

- 5. The Chairperson desired that the units found operating in non-conforming areas/residential area without licence and sealed/in the process of sealing, industrial power supply should be disconnected. This will ensure that the prohibited activities are not resumed even from the back door. The availability of domestic power supply would check the mis-use by the occupier.
- 6. The Commissioners of DMCs informed that the survey and the action to be taken pursuant thereto, being a time consuming process, sufficient time is required to complete the process under Step-3.
- 7. The Commissioner of SDMC informed that by now only 42 wards have been surveyed out of 104 wards.
- 8. The Chief Secretary advised that the three DMCs should survey and complete the entire process ward-wise. The Chief Secretary desired that reasonable time-line for completion of the exercise under Step-3 should be given by the three DMCs as sufficient time has already lapsed. The Chief Secretary directed the three DMCs to submit a detailed report to the Oversight Committee in terms of the directions already issued.
- 9. The Chairperson and the Chief Secretary desired that the list of industries with nature of activity, category of the unit, duration of its operations has also to be sent to DPCC for determining Environmental Compensation (EC) as per the order of the Hon'ble NGT dated 18.7.2019 in OA No. 601/2018. This may be done by the Department of Industries after compiling the data from all the local bodies.
- 10. The Chairperson referred to the media reports on sealing of 'Bhattis' of Potters ('Kumhar') who have been in this trade for generations. The Chairperson was eager to know whether before sealing, any awareness was created to make them switch over to PNG, whether any reasonable time and opportunity was given to them before sealing their 'Bhattis' just before Diwali. Further the Chairperson desired to know whether any NGO was associated to assist them in paper work for obtaining PNG connection or to provide them subsidy in view of their economic condition.

11. The Chairperson was informed that the sealing action has been carried out in Uttam Nagar and necessary steps to provide them assistance to switch over to PNG was assured.

Meeting ended with thanks to the Chairperson and the Chief Secretary.
